If you do not have copies of some/all of the below records, and the court or agency no longer has these records either, providing documentary evidence from the court/agency confirming their unavailability may avoid delay in the processing of your application.

- **Charging Document:** e.g., Complaint, Citation, Indictment, Information, etc.
- **Police/Arrest Report:** Police reports are separate from court records and the complaint/citation, except on some minor offenses, and must be requested from the records department of the law enforcement agency that made the arrest—not the court.
- **Disposition Document(s):** This documentation may vary depending on the outcome of this matter. Any sentencing orders must be provided; other common documents include a probation discharge order or a dismissal order (whether issued as the initial disposition or after completing probationary/diversion conditions).
- **Other Documents (if applicable):** Depending on the nature of this case, additional substantive court records may have been filed in it, including but not limited to: a plea agreement, a presentence investigation report, documentation from having completed certain court-ordered requirements, an appellate opinion, etc.
